In contravention of article 13 of the General Terms and Conditions, any objections to an incomplete or incorrect statement should be notified in writing by the Accountholder(s) to the Bank within a period of 30 (thirty) days from the date of its receipt. If no such notification is made during this period the Bank will become entitled to treat the statement in question as approved by the Accountholder(s).

The Bank requires to receive in any case the following documentation (for each Accountholder)

Accountholder(s) who elect Credit Europe Direct Banking will receive by postal mail a unique customer number and PIN.

The Accountholder(s) hereby instruct(s) the Bank to accept and execute orders given concerning the account(s) as well as any other assets that the Bank may hold in name of the Accountholder now or in the future. This includes orders given by telephone, telex, fax or any other electronic means or tools. The Accountholder(s) undertakes to indemnify and hold the Bank harmless from and against any and all losses and/or risks incurred by the Bank acting upon such orders, even if they are fraudulently transmitted by unauthorized third parties or where they are duplicated by the Accountholder. Notwithstanding the foregoing the Bank retains the right not to execute orders if it is not satisfied with the identity of the person(s) giving such orders. The Bank reserves the right to require that any other documentary proof of such authority be certified, verified or notarized if not received in original.

General terms and conditions of our Bank, as well as the Direct Banking terms and conditions can be inspected at www.crediteurope.nl and the accountholder(s) confirm to have read and accepted these terms without any restriction.

The General Conditions of Credit Europe Bank N.V. (Holland) / Netherlands' Banking Association and the Direct banking terms and conditions also govern the Accountholder's business and legal relations with the Bank. In case of discrepancies between the General terms and conditions and the Direct Banking terms and conditions, the latter will prevail.
